- Enroller shares were calculated for demonstration purposes using August 2019 average numbers.
- Intro Bonuses vary based on Product Packs purchased. If a Partner enrolls with the \$197 Pack, the bonus is \$50.
- Leadership Shares are determined by the lowest title maintained during any given quarter.
- Business Building Bonuses, Personal Generation Bonuses, and 1+ Generation bonuses are calculated based on your team's Commissionable Volume during any given month.
- You receive 1 Enroller Share for every new personally enrolled Partner that enrolls with \$200+. You receive 1 Enroller Share for every two Level 2's that enroll with \$200+.
- To earn Executive Director Lifestyle Bonus, you must achieve 1,750 PGS outside of your Directors. This grace period lasts for 3 months, then your requirement would be 3,000 PGS.
- Title & Mentor bonuses are paid for 3 consecutive months when titles are maintained.
